Transportation - associated with provision of services requested	Per mile at current state rate
Plan Development	\$50 per hour up to 2 hours
Incentive Payments	<p>\$250 one- time payment for meeting the following criteria:</p> <p><b><u>Direct Placement</u></b></p> <ul style="list-style-type: none"> <li>- 30 hours/week or more</li> <li>- \$1.00 an hour, or more, above current minimum wage</li> <li>- Medical benefits</li> </ul> <p><b><u>Supported Employment</u></b></p> <ul style="list-style-type: none"> <li>- 30 hrs/wk or more</li> <li>- \$1.00 an hour, or more, above current minimum wage</li> <li>- Medical benefits</li> <li>- Natural supports</li> </ul>
Extended Assessment - Trial Work (Integrated)	Plan Development Fee, \$25 per hour for up 6 months maximum of 90 hours, Plus travel ongoing
Extended Assessment - Extended Work Experience (Must be done in the most integrated component of a facility based program)	Plan Development Fee, \$20 per hour for up 6 months maximum of 90 hours, travel ongoing
Community Based Assessment - Unpaid	Plan Development Fee, \$40 per hour for up 6 months maximum of 90 hours, travel ongoing
Community Based Assessment - Paid	Plan Development Fee, \$40 per hour for up 6 months maximum of 90 hours, travel ongoing
Work Skills Assessment - Community Based	Plan Development Fee, \$40 per hour for Community Based not to exceed 90 hours or 6 months, travel ongoing
Work Skills Assessment - Facility Based	Plan Development Fee, \$20 per hour for Facility Based not to exceed 90 hours or 3 months, travel ongoing
Life Skills Training Program - not to exceed 55 days	<p>Plan development Fee, \$200 for administering Daniel Memorial Independent Living Scale, \$3,575 to be authorized but paid at following milestones:</p> <ul style="list-style-type: none"> <li>- \$1,787.50 at 25 service days</li> <li>- \$1,787.50 upon completion</li> </ul> <p>Payment will be prorated at \$65/day if client drops out or if it is determined to not be meeting a successful outcome</p> <p>Travel ongoing</p>

Work Adjustment - Paid non-integrated setting - 4 or more clients	Plan development fee, \$1,800 to be authorized and paid at 20 days, 40 days, and upon completion in the amount of \$600 payments. Payments prorated at \$30/day if client drops out or person is not successfully reaching goals
Work Adjustment Paid integrated setting 1:1 ratio, 1:2 ratio, or 1:3 ratio	<ul style="list-style-type: none"> <li>• For 1:1 \$3,600 to be paid at 30 hours, 60 hours and upon completion in the amount of \$1,200</li> <li>• For 1:2 \$1,800 to be paid at 30 hours, 60 hours and upon completion at \$600</li> <li>• For 1:3 \$1,260 to be paid at 30 hours, 60 hours and upon completion at \$420</li> <li>• Travel ongoing</li> </ul>
Job Coaching - other than Supported Employment	Plan development, \$40.00 per hour not to exceed 100 hours or 6 weeks in duration, Travel ongoing
Direct Placement	<ul style="list-style-type: none"> <li>• Plan development</li> <li>• \$830 Plan and job development - paid once job has been developed</li> <li>• \$600 placement/follow up paid at: <ul style="list-style-type: none"> <li>- One week on the job</li> <li>- 30 days</li> <li>- 60 days</li> <li>- Successful closure</li> </ul> </li> <li>• Incentive Payments (see above)</li> <li>• Travel ongoing</li> </ul>
Supported Employment	<ul style="list-style-type: none"> <li>• Plan development</li> <li>• \$830.00 Plan and job development paid once job is developed</li> <li>• \$600.00 placement/follow up - to be paid in \$150.00 milestone payments at: <ul style="list-style-type: none"> <li>- One week on the job</li> <li>- 30 days</li> <li>- 60 days</li> <li>- Successful closure</li> </ul> </li> <li>• Incentive Payments (see above)</li> <li>• Travel ongoing</li> </ul>
Job Coaching - Supported Employment	\$40 per hour - not to exceed 100 hours in 18 month period
